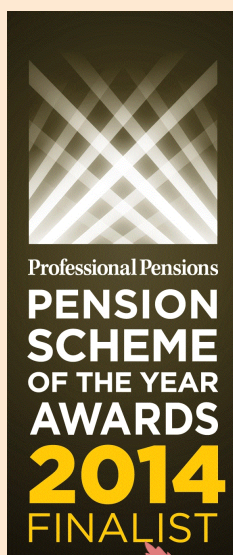

National Fraud Initiative

The Greater Gwent (Torfaen) Pension Fund has a duty to protect the public funds we administer. This includes our participation in the Government's National Fraud Initiative (NFI), and we may share information with other bodies responsible for auditing or administering public funds for the purpose of preventing and detecting fraud.

NFI operates under the Audit Commission Act 1998 to protect the public purse by matching data across public sector organisations, to prevent and detect fraud.

The NFI exercise is carried out every two years. Since the initiative started in 1996 it has helped trace £1.17 billion in fraud, error and overpayment.

The 2014 NFI is currently being undertaken and we are required to provide information about pensioner members to the Audit Commission for data matching.

NFI operates under the '*Code of Data Matching Practice*' to ensure compliance with legislation, in particular the Data Protection Act 1998. You can read further information about data matching, and download the Code, on the Audit Commission website at:

Increase to pensions in 2015

At the time of writing, the annual increase to LGPS pensions in 2015 has not been formally announced, but we expect that the full increase may be **1.2%**. This figure is based on the Government's Consumer Prices Index (CPI) for September 2014.

The 2015 pensions increase will apply from the 6th of April. This means that you won't get the full increase on your April pension payment, as the increase does not apply to the pension from the 1st to the 5th of April.

In some cases, LGPS pensions won't increase by 1.2% from 6th April:

- **New pension members -** if you retired part way through the year then you'll receive a partial increase to your LGPS pension from 6th April.

For example, if you retired at the end of September 2014 then you'll get about half a year's increase from 6th April 2015.

- **If you paid into the LGPS between 1978 and 1997 and you have reached your State Pension Age -** then part of your pensions increase will be paid to you by The Greater Gwent (Torfaen) Pension Fund and the balance will be paid to you in your State Pension.
- **If you retired before age 55 -** your pension won't increase until you reach the age of 55, unless you were retired by your employer on the grounds of permanent ill health.

Payslips -

We'll post a payslip to you in **March, April and May 2015** so that you can see the effect of the pensions increase to your pension.

We'll only send a payslip to you at other times if your monthly pension payment changes by more than £1.

Pension Fund Annual Report and Accounts

The Greater Gwent (Torfaen) Pension Fund has published its Annual Report and Accounts for 2013/14.

In summary – within a period of what some might call 'benign turbulence', where uncertainty remains but at less volatile levels than in recent years, developed equity markets have been generally strong. The result is that the Fund has achieved a healthy annual investment return of 7.49% with a positive increase in its market value from £1,924 million to £2,081 million.

The year also saw the number of active contributors within the Fund rise for a second consecutive year, which is helpful against a continuing trend of increasing numbers of pensioners and deferred members.

Do you have a question about your tax code?

HM Revenue & Customs (HMRC) gives The Greater Gwent (Torfaen) Pension Fund a tax code to apply to your pension.

If HMRC changes your tax code then they will give us a new tax code to apply.

Unfortunately we're not able to answer any queries you may have about changes to tax codes - HMRC don't tell us why a tax code has been changed, or how they have calculated it, only that we have to apply it.

We cannot change the tax code that is being applied to your pension unless HMRC instruct us to do so.

If you have a query about your own tax code then **you will have to contact HMRC directly.**

If you do contact HMRC, they will ask you for your:

- **National Insurance Number**
- **'PAYE reference'** for your pension from The Greater Gwent (Torfaen) Pension Fund, which is: **948 / T440N**
- **6 digit LGPS pension reference number**

Are you planning to move house this year?

If you're planning to move house, please remember to put it on your **'To Do List'** to write to us with your new address – our contact details are on the front of this newsletter.

Every year we lose touch with a number of pensioners who move house and forget to tell us.

If any post we send to a pensioner is returned to us marked **'Not at this Address'** or **'Return to Sender'**, and we are subsequently unable to make contact with that pensioner, then we will suspend payment of the pension until we hear from them.

Let us know if you change your bank account

If you want us to pay your pension into a different bank or building society account then you must tell us, in writing – **we can't take a change of bank account over the phone.** If you write to change your account, please include the name of the account holder.

If you let us know about your new bank account **by the 15th of the month** then we should be able to make sure the change of bank account is processed in time for that month's payday.

If your letter reaches us after the 15th of the month then we may try and make a payment to your existing bank account. If this account is closed then your old bank will return the payment to us and we will forward it to your new account - this will obviously cause a delay so, to avoid this, please let us know as early as you can.

Moving abroad?

If you are planning to move abroad you will be pleased to know that we can pay your LGPS pension into an overseas bank account via Western Union. You are not charged for this service.
